The quality seal of origin stands for a sustainable production with an added value of at least 80% in the EU countries. Standardised and independent controlling systems on behalf of the initiative are offering confidence.

The quality seal of origin of Initiative MADE IN EU aims to bring about the standardised and transparent labelling of your products, as well as on packaging, in catalogues, sales prospectuses, manuals, etc. It can also be used on websites, in e-commerce or other digital media. Raising awareness and encouraging solidarity over local products are processes that have been noted for some time now.
